#### **Preamble**

Rolling Graduation may allow students to graduate at times other than the May and November Congregations. The rolling graduation schedule allows students who do not meet the requirements for graduation for the Spring Congregation, to graduate at other specific times during the academic year.

## **Policy**

- 1. Students must fulfill all the requirements for graduation from the MD Undergraduate Program.
- 2. Rolling graduation will be considered for students who have not fulfilled all of the requirements for graduation from the program by the time of the usual Spring Congregation.
- 3. The recommendation for graduation of MD students requires the approval of the Faculty of Medicine, usually at a Full Faculty Meeting or a meeting of Faculty Executive.
- 4. The UBC Vancouver Senate may confer the MD degree at one of their regular meetings.

#### **Procedure**

- 1. Once all of the requirements for graduation are completed, approval by the Regional Student Promotions Subcommittee (RSPS) and the Student Promotion Review Board (SPRB) is required.
- 2. Recommendation for graduation must be approved by the Faculty of Medicine; this can be done at a Full Faculty Meeting or, if necessary, at any of the regularly scheduled meetings of the Faculty Executive.
- 3. The UBC Vancouver Senate may confer the MD Degree at a regularly scheduled meeting. The granting of a degree will be noted on the student's transcript once approved by the UBC Vancouver Senate.
- 4. The degree diploma will only be issued once the degree is conferred at or after the Congregation following approval.
- 5. The College of Physicians and Surgeons of BC is prepared to extend student educational licenses, as appropriate, for students who require extra time to complete their graduation requirements.
- 6. Every candidate for the MD degree must make a formal application for graduation. Students may make a formal application for graduation via the Student Service Centre (SSC)

This application must be submitted regardless of whether or not the student intends to participate in the scheduled graduation ceremonies. If the request to graduate is not approved by the Faculty of Medicine or the UBC Vancouver Senate, a reapplication for the next congregation will be required.

7. No student will receive a graduation diploma until all academic fees have been fully paid (see Financial Hold).
