



6.0 COVID-19 RESPONSE

- Dean Kelleher outlined the COVID-19 Full Activity Report, which was circulated in full;
- Sections of the report were further outlined by the following:
 - Education
 - The steps that the Faculty of Medicine has taken in response to COVID-19 aligns with the direction provided by UBC Central. These steps fulfill individual program requirements and are intended to ensure learner safety while optimizing the student learning experience through the creative use of technology, connectivity and compassion;
 - A Virtual Education Resource Hub was created through the Office of the Vice Dean, Education, to assist in pivoting capabilities within the Faculty of Medicine to support programs and preceptors as they continue their transition to best practices for online instruction
 - Research
 - Established the COVID Research Coordination Initiative, which supports COVIDrelated research coordination across UBC, PHSA, Vancouver Coastal, Providence, SFU and other partners to streamline and coordinate research and attract more funding;


- Information will be sent out shortly on the process for the phased in resumption of on-site research in a limited capacity, with the priorities being the safety of staff, personnel and the general public.
- Operations
 - Initial focus was on business continuity and has now started to shift into plans for re-entry of essential faculty and staff who must be onsite at the University;
 - Due to the mixed use of the various buildings, re-entry will be complicated as there are multiple elements to be coordinated, and only faculty and staff who are required to be onsite will be approved to return at this time.
- Planning horizons still underway. Current focus is building a framework to undertake all the planning in a coordinated way. Further details will be released in the coming weeks.

- Brief update on the Royal College of Physicians and Surgeons' considerations for the examination/certification process of 2020 cohort of residency graduates.


