The MD Undergraduate Program (MDUP) has the responsibility to determine students' readiness for advancement, promotion, and graduation. It also has the responsibility to assign students' UBC academic standing.

The MDUP is committed to a fair and formal process for academic review and promotion in accordance with the Committee on the Accreditation of Canadian Medical Schools (CACMS) Element 9.9 Single Standard for Promotion/Graduation and Appeal Process.

Course Pass/Fail

1.1. Criteria for COURSE pass

a) Criteria for each course are provided in course syllabi and assessment packages. A failure to meet the specified criteria results in course failure.

1.2. Consequences of COURSE Failure

- a) If a student fails a course, an F is entered on the Official Transcript of Academic Record.
- b) Except as noted below in b) iii, a student who has failed an assessment modality in a course will be offered a supplemental assessment of that modality.

Policy and Procedure

- i. If the student successfully completes the supplemental assessment, the student will pass the course. If a supplemental is granted and passed, the transcript will be changed. For the failed course, the F will be changed to an S. The Supplemental will show on the line below and a P will be entered. These are permanent notations on the Transcript.
- ii. If a student fails a supplemental assessment the course grade "Fail" will be permanent.
- iii. A supplemental assessment will not be offered if a student fails the WBA assessment modality or fails a course while on Academic Probation in any year.
- c) A student who has failed a course in Year 1 or 2 cannot advance to the next term. The student must repeat the course as soon as possible (usually the next academic year) in order to advance in the Program.
- d) A student who is required to repeat a course(s) will be charged tuition based on the number of credits of the course (s) to be repeated.
- e) A student who fails MEDD 448 or MEDD 449 must repeat and successfully pass the course to graduate.

Advancement

2.1. Criteria for Advancement

- a) Passed all of the term and year-long courses, or
- b) Has course failures or incomplete coursework/assessments (including the Progress Tests) that can be successfully completed before the end of the academic year in accordance with assessment policies. In this situation, provisional advancement is granted pending the outcome of the outstanding coursework/assessments.

2.2. Consequences of Failure to Advance

- a) A Year 1 or 2 student who fails a first term course (MEDD 411 or 421) and its supplemental assessment, where provided, cannot advance to Term 2 and will be required to repeat the course the next academic year. The Official Transcript of Academic Record will show Failed.
- b) A Year 1 or 2 student who fails a second term course (MEDD 412 or 422) and its supplemental assessment, where provided, cannot advance and will be required to repeat the course in the next academic year. The Official Transcript of Academic Record will show Failed.
- c) A Year 1 or 2 student who fails a course after Term 1 will not be allowed to continue year-long courses (MEDD 419 and 429).
- d) A Year 3 student who fails MEDD 431 and its supplemental, where provided, cannot advance and will be required to repeat the Course in the next academic year. The Official Transcript of Academic Record will show the course as Failed.
- e) A Year 4 student who fails a course in Year 4 (MEDD 440, 448, 449, 451) or its supplemental, where provided, cannot graduate until the course is successfully completed. The Official Transcript of Academic Record will show the course as Failed. (See Failure of Supplemental Component/ Course/ Programmatic Assessment in the Year 4 Assessment Package.) Consequences can include the student not graduating with their Class, Rolling Graduation and/or delayed entry into residency.

Promotion

3.1. Criteria for YEAR failure: A student will not be promoted and will fail the year in the following circumstances:

Policy and Procedure

a) Based on course failure:

Year 1 and 2 courses (MEDD 411, 412 and MEDD 419; MEDD 421, 422 and MEDD 429): Failure of two or more courses on the first attempt that year.

Year 3 (MEDD 431 – one year-long course):

Failure of MEDD 431 constitutes a failure of Year 3, see Policy 004 and Y3 WBA Review & Support Process.

Year 4 (MEDD 440 (electives), 448 (TIPP), 449 (FLEX), 451 (OSCE)) - see Policy 004 and Y4 WBA Review & Support Process:

- Failure of MEDD 440, or
- Failure of MEDD 448 and MEDD 449 and subsequent failure of a supplemental where offered, or
- Failure of the Year 4 Objective Structured Clinical Examination (MEDD 451, OSCE) and subsequent failure of a supplemental OSCE, where provided.
- b) Based on professionalism deficiencies

Failure to meet professionalism standards during Program curricular and University sponsored activities. A student may fail the year if <u>professionalism standards</u> are not met, even if the student has passed all courses.

3.2. Consequences of YEAR Failure

- a) Except as outlined in 5.1 below, a student who fails the year will be permitted to repeat the year in its entirety
- b) A student who has failed a year and is permitted to repeat the year will be assigned the academic standing On Academic Probation for the duration of the repeated year. The student's academic standing will be reviewed by the SPRB at the end of the repeated year.
- c) As set out in University policy, the student's Official Transcript of Academic Record will show the grades for each course earned during the failed year. If the student is permitted to repeat the year, the grades earned during the repeated year will also be documented in the transcript.
- d) A student who is required to repeat a year will be charged full tuition for the repeated year.

Academic Probation

4.1. Criteria for On Academic Probation

A student will be assigned the academic standing On Academic Probation in any of the following circumstances:

- a) The student is required to repeat a year due to poor academic performance, which includes performance in the professionalism domain.
- b) The student engages in an egregious breach of professionalism standards, or demonstrates repeated failure to meet professionalism standards despite remediation efforts.
- c) A student subsequently breaches, or fails to meet, any limitations or conditions imposed in writing by the SPRB.

4.2. Consequences of On Academic Probation

a) A student assigned the standing On Academic Probation will be permitted to remain in the Program subject to the Terms of Academic Probation. Failure to meet the Terms of Academic Probation will result in the student being required to withdraw from the Program.

Policy and Procedure

- b) While On Academic Probation, a student:
 - may not serve on appointed committees of the University or Program or related provincial or national committees;
 - ii. may not participate in Program or University affiliated extra-curricular activities, including research, without permission from the student's Regional Associate Dean;
 - iii. may not participate in electives, courses or parts of courses out of province;
 - iv. is not eligible for participation in an Integrated Community Clerkship (while On Academic Probation);
 - v. will not be granted an Educational/Career Development LOA.
 - vi. will not be eligible for Faculty of Medicine-adjudicated awards.
- c) If a student is assigned the standing On Academic Probation, there will be a notation on the student's Official Transcript of Academic Record for the session(s) associated with the probation. This will be a permanent notation on the Transcript. A student assigned the standing On Academic Probation will not be offered a supplemental assessment in any failed course.

Requirement to Withdraw from the Program (Dismissal)

5.1. Criteria for Requirement to Withdraw from the Program (Dismissal)

A student will be required to withdraw from the Program if:

- a) A student with the academic standing On Academic Probation:
 - i. fails a course (supplemental assessments will not be offered)
 - ii. fails to meet the Terms of Academic Probation.
- b) A student fails any two years while registered in the Program (may be the same year level or different year levels, and need not be consecutive), in accordance with the University's <u>Advancement</u> <u>Regulations</u>.
- c) A student fails a course that the student has previously failed and been permitted to repeat. <u>See UBC</u> Calendar
- d) There is persistent or recurring failure to meet professionalism standards despite remedial efforts, such that, in the judgement of the SPRB, there is no reasonable expectation that the student will be successful in meeting the program requirements.

Graduation

A student must successfully complete all of the academic requirements for the Doctor of Medicine degree to be recommended for graduation by the SPRB.
