2024 CLINICAL FACULTY AWARD FOR EXCELLENCE IN
RESEARCH (CLINICAL OR APPLIED)**

The Clinical Faculty Award for Excellence in Research (Clinical or Applied) recognizes Clinical Faculty members who have demonstrated excellence in research within their clinical faculty position with the Faculty of Medicine.

NOMINATION PROCESS:

This award is open to all Clinical Faculty members appointed in the Faculty of Medicine who have demonstrated excellence in either clinical or applied research. Nominees must hold an active Clinical Faculty appointment at the time of nomination.

***Two awards are available; one for early career (up to 10 yrs) and one for mid/late career (beyond 10 yrs) ***

Nominations can be made by any two Clinical or Full-Time Faculty members, medical students, residents or any other students in a clinical program within the Faculty of Medicine. A signed nomination form (attached) should be accompanied by a brief citation for use at the Awards Ceremony, a letter from the nominators, letters of support (maximum of 4), and a summary of available research abstracts. Nominators will complete all documentation and submit the completed nomination package to the Dean. After checking for eligibility and completeness, the Dean will forward dossiers to the Adjudication Committee.

Nominations must be submitted to fom.recognition@ubc.ca no later than 4:00 pm on Friday, June 14, 2024 (strict deadline).

NOMINATION GENERAL GUIDELINES:

The Adjudication Committee will resolve questions concerning eligibility. An Award may not be granted every year. The identities of the nominees will not be made public unless they win the award. Decisions made by the Adjudication Committee are final and may not be appealed. Posthumous awards will not be made. Nominators should not expect staff members of the Dean's Office or Adjudication Committee to assist with the preparation of a nomination beyond general advice concerning the regulations and proper forms to use; nor will they offer opinions as to a nomination's chance of success.

JUDGING CRITERIA: (to be addressed in the nomination letter)

- Nominee has demonstrated excellence in clinical or applied research, which can include quality improvement or program development research.
- Nominee has used or developed effective research strategies for use in a clinical or applied environment.
- Nominee's excellence in research inspires, influences and motivates peers and students/residents.
- Nominee's research contributes to and progresses knowledge in their clinical or applied field.

ADJUDICATION COMMITTEE:

The Clinical Faculty Awards Adjudication Committee will consist of a Chair (Director, Clinical Faculty Affairs) and four other Clinical Faculty members from the Faculty of Medicine, chosen by the Chair:

- (1) representative from Postgraduate Education
- (2) representative from the Clinical Faculty Affairs Committee
- (3) previous recipient
- (4) representative from a non-MD professional program
