**2024 BILL AND MARILYN WEBBER LIFETIME ACHIEVEMENT AWARD**

**Deadline: Friday, June 14, 2024**

*The Bill and Marilyn Webber Lifetime Achievement Award recognizes extraordinary members of the Faculty of Medicine who have sustained distinguished careers at UBC. All nominees should have demonstrated a strong commitment to living the Faculty of Medicine values of respect, integrity, compassion, collaboration, equity.*

The Bill and Marilyn Webber Lifetime Achievement Award is made in recognition of sustained scholarly achievement in the areas of research, teaching and/or service as defined by the guidelines for promotion in the Guide to Promotion & Tenure Procedures at UBC.

**ELIGIBILITY**

- Nominees must be at the rank of Professor, Professor Emeritus/Emerita, Professor of Teaching, Clinical Professor or Clinical Professor Emeritus/Emerita
- Nominees must have held an appointment at UBC for at least 15 years.
- At the time of nomination, the nominee must be an active member of the UBC Faculty of Medicine, which includes all [distributed sites](#), [departments](#), [schools](#), and [other academic units](#)

**NOMINATION PROCESS**

The following elements must be included in the nomination package:

- Completed nomination form. Nominations must be made by any three Professors, Professors Emeritus/Emerita, Professors of Teaching, Clinical Professors or Clinical Professors Emeritus/Emerita in the Faculty of Medicine.
  - To avoid duplication, the Governance & Recognition team should be informed of the intention to nominate and the name of the proposed nominee in advance of submitting the nomination.
- Nominee's curriculum vitae and publication list.
- Up to four external arms-length references addressing the criteria of the award. Referees should be individuals of stature in the nominee's area of interest. References are to be completed using the reference forms found on MedNet (*in lieu of letters*).
- The nominators must indicate that the nominee has been informed of the nomination and is willing to stand.

Provided that the nomination package is updated every year, nominations will stand for three consecutive years. It is the nominators' responsibility to keep a nomination current. The FoM Awards Advisory Group will resolve questions concerning eligibility. An award may not be granted every year. The identities of the

nominees will not be made public unless they win the award. Recipients are selected by the FoM Awards Advisory Group and presented to the Dean for final approval. Decisions are final and may not be appealed. Posthumous awards will not be made. Nominators should not expect members of the Dean's Office or Advisory Group to assist with the preparation of a nomination beyond general advice concerning the regulations and proper forms to use.

**Nomination packages are to be organized into a single PDF file and submitted electronically to the Governance and Recognition team ([fom.recognition@ubc.ca](mailto:fom.recognition@ubc.ca)) by 4:00 p.m. on Friday, June 14, 2024. This is a strict deadline.**

**SELECTION CRITERIA (to be addressed in references)**

Nominations will be evaluated against the following criteria:

- Evidence of distinguished scholarly activities sustained throughout the career.
- Evidence of the nominee's level of national and international recognition.
- Evidence that that nominee has, and continues to exhibit and promote commitment to the vision, mission and values of their team, unit and the Faculty of Medicine.
